COURSE DESCRIPTION: This Advanced ADR Course will cover a full range of methods and procedures used in both the prevention and settlement of disputes from facilitation, advisory opinions and partnering to binding arbitration and mini-trials. All aspects of mediation including binding mediation, non-binding mediation, evaluative mediation, technical mediation, etc. will be covered. Binding and non-binding arbitration, including advocacy arbitrations, will be reviewed along with the hybrid ADR processes such as med-arb and arb-med. How to handle multiple party mediations and arbitrations, high-low arbitrations, structured settlements, online/electric dispute resolution and other ADR techniques will be covered. There will also be a general review of Dispute Review Boards and Construction Settlement Boards and their use of the ADR processes. There will also be a review of some of the most noteworthy court decisions concerning the ADR processes.
